CONDITIONS OF ENTRY

- ENTRIES: Up to **3 WORKS** per member. Members can also submit cards for sale. (boxed or in container)
- ORIGINAL WORK: **ALL WORK MUST BE FOR SALE. Each work must be the ORIGINAL WORK of the Artist and must be signed by the Artist (prints and/or photography will not be accepted).**
THE COMMITTEE RESERVE THE RIGHT TO NOT HANG THE WORK & NO REFUNDS WILL BE GIVEN
- IDENTIFICATION: Each entry must be clearly labelled on the back with the following information –
1. TITLE OF WORK
2. NAME
3. PRICE OF THE WORK
4. MEDIUM
PAINTINGS NOT LABELLED WITH THIS INFORMATION WILL NOT BE HUNG.
- FRAMES: ALL works must have framer's hanging cords attached, or **framer's (only) wire**. D Rings are acceptable. **Screw eyes, sharp or metal projections on the back of paintings will not be accepted.** **Stretched canvas works** will only be accepted if they are on a Gallery thickness **40mm timber frame** and must be stapled on the back with **edges painted**.
Wet paintings will not be accepted.
NOTE: A diptych/triptych entry = 1 entry if ALL panels are within the **MAXIMUM WIDTH**
Paintings that require to be "grouped" are still multiple paintings.
- A beautiful painting needs a quality frame – WELL MADE, UNMARKED, AND SPOTLESSLY CLEAN!**
Our Art Exhibition and Sale of Paintings is a prestige and professional event bringing admiration and compliments from far and wide. We know most artists are happy to comply but there are some artists who do not present their artworks in a professional manner.
- SIZE LIMIT: **Overall maximum WIDTH must not exceed 90cm (35 inches) each work.**
- ENTRY FEE: **A NON-REFUNDABLE ENTRY FEE** of \$15 per painting as well as for cards will be charged.
25% COMMISSION will be charged on all paintings (not cards) sold during the Exhibition.
- SOLD PAINTINGS: Paintings sold during the exhibition can be taken by the purchaser. The artist will be contacted and may replace their entry, for an additional entry fee.
- UNSOLD PAINTINGS: Unsold paintings cannot be removed until **AFTER EXHIBITION CLOSING (Saturday 31 October 5pm).**
